CALL TO ORDER

Chairman David John called the meeting to order at 3:58 pm with a quorum of members present; the following procedures were duly had and taken.

APPROVAL OF MINUTES

Charles Kromer moved to accept the July 1, 2013 minutes as presented. Leigh Irvin seconded. Motion carried.

STAND DOWN HOMELESS GRANT

Beverly Charley, Workforce Solutions addressed the Commission regarding the grant application for the Stand Down Homeless Event taking place in October. This event helps veterans and non-veterans from all cultural backgrounds. Bob Campbell stated that this event does meet the intent of the grant application. Ms. Charley stated that they have various sponsors, merchants and residents, who have already donated to this event. Charles Kromer moved to accept application in the amount of \$800.00. Al Garcia seconded. Motion passed.

NATIVE AMERICAN INITIATIVE TALKING POINTS

Chairman David John opened up the discussion of the Summary Talking Points. The Commissioners wanted to include CHAP and the Round Table Minority to the list. Chairman John also would like to see if we could publish the Talking Points in the Navajo Times, Daily Times and Cibola Beacon newspapers. He asked Bob Campbell to get quotes on the price for each newspaper. Chairman John asked the Commissioners to look over and will bring this back to the next regular meeting to discuss and make comments or changes. Al Garcia asked if the City of Farmington totally funds the Indian Center. Bob Campbell replied yes. The Commission also discussed putting in the Four Winds Detox Center.

DEMOGRAPHIC ANALYSIS OF ADULTS ARRESTED REPORT

Bob Campbell opened up the discussion going over the main points of the report. He had spoken with Captain McPheeters from the Police Department and he stated that the numbers are skewed. Most of the crimes are committed by inebriates against each other. The City of Farmington is working with PMS and SJRMC and have indentified the top 14 persons with the most arrests. Social workers will be working with these persons to see if they can stay out of jail.

OLD BUSINESS

Chairman David John opened up the discussion regarding keeping the grant applications at the amount of \$800.00 because of the decrease of funds given to the Community Relations Commission. After discussion regarding the amount of grants applied for and received by various entities, it was decided to leave the amount at \$800.00 maximum.

COMMISSION BUSINESS

Chairman David John opened up a discussion regarding helping out at the Shiprock Fair by setting up a booth for the Commission to man. Bob Campbell stated that the events have to be done within the city limits but the Commission could donate money or items for advertising or promotion. It was decided by the Commission to provide bottles of water for the Fair.

Chairman David John revisited the idea of the Commission putting together the Food Festival. Bob Campbell stated that if the Community Relations Commission wanted to do some event like this, that they could just sponsor the space and have vendors come in and take care of the food. Chairman John stated that he would like to keep this open for more discussion.

Chairman David John asked Bob Campbell if Neil Johnson was coming back to the Commission. Bob replied that he would have to talk to the Mayor regarding this matter.
