





Maker's Market Vendor's Agreement

- 1. By signing and paying the booth fee, you accept and will follow the rules of this contract available online and in print. Fees are \$8 per day or \$110 for the season (\$5 per week). The Season runs from June 7, 2018 through October 25, 2018. It is also possible to purchase a 5 market pass for \$25.
- 2. A contract MUST be filled out and signed by the person or persons operating the booth during Market hours. Contracts and payment (payable by check or money order only) may be dropped off at the office of Downtown Farmington: A MainStreet Project at 119 W. Main Street, Farmington, NM 87401.
- 3. The Eligibility and Requirements set out in the Market Rules must be followed.
 - a. Seller must provide their own tent, tables and displays.
