

## RESOLUTION NO. 2019-1733

A RESOLUTION APPROVING THE SAN JUAN BOULEVARD PAVEMENT RESURFACING PROJECT, SOUTH BUTLER AVENUE TO EAST MAIN STREET, PARTICIPATION IN THE LOCAL GOVERNMENT TRANSPORTATION PROJECT FUND PROGRAM ADMINISTERED BY NEW MEXICO DEPARTMENT OF TRANSPORTATION AND ACCEPTING FUNDS FOR SUCH PROJECT.

WHEREAS, the City of Farmington and the New Mexico Department of Transportation (NMDOT) have entered into a grant agreement under the Local Government Transportation Project Fund Program for a local road project; and

WHEREAS, San Juan Boulevard is designated as a minor arterial, as shown on the City's Major Thoroughfare Plan, which carries approximately 13,100 vehicles per day, and provides an alternate connection between Butler Ave and East Main Street located in the center of Farmington with connections to US64 and NM516; and

WHEREAS, the San Juan Boulevard Resurfacing Project - Pavement Preservation Project, South Butler Avenue to East Main Street, will include cold milling with hot-mix asphalt inlay; and

WHEREAS, the total cost of the project will be \$575,000 to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 95% or \$546,250.00; and,
- b. City of Farmington's proportional matching share shall be 5% or \$28,750.00.

WHEREAS, the City of Farmington shall pay all costs, which exceed the total amount of \$575,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF FARMINGTON:

SECTION 1:

That the City Council of the City of Farmington does hereby approve the "San Juan Boulevard Pavement Resurfacing Project" located on San Juan Boulevard between South Butler Avenue and East Main Street in the City of Farmington.

SECTION 2:

The agreement terminates on June 30, 2022 and the City of Farmington incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

SECTION 3:

That the City Council of the City of Farmington does further represent that funds, equipment, labor and materials representing the total cost of the proposed project will be budgeted in Federal Fiscal Year 2020 and will be available when the agreement of such project becomes effective.

SECTION 4:

That the City Council of the City of Farmington does further authorize the Mayor of the City of Farmington to enter into a Grant Agreement for Project Control Number LP50009 with the New Mexico Department of Transportation for the LGTPF Program for the year 2019 for the San Juan Boulevard Resurfacing Project - Pavement preservation within the control of the City of Farmington in New Mexico.
