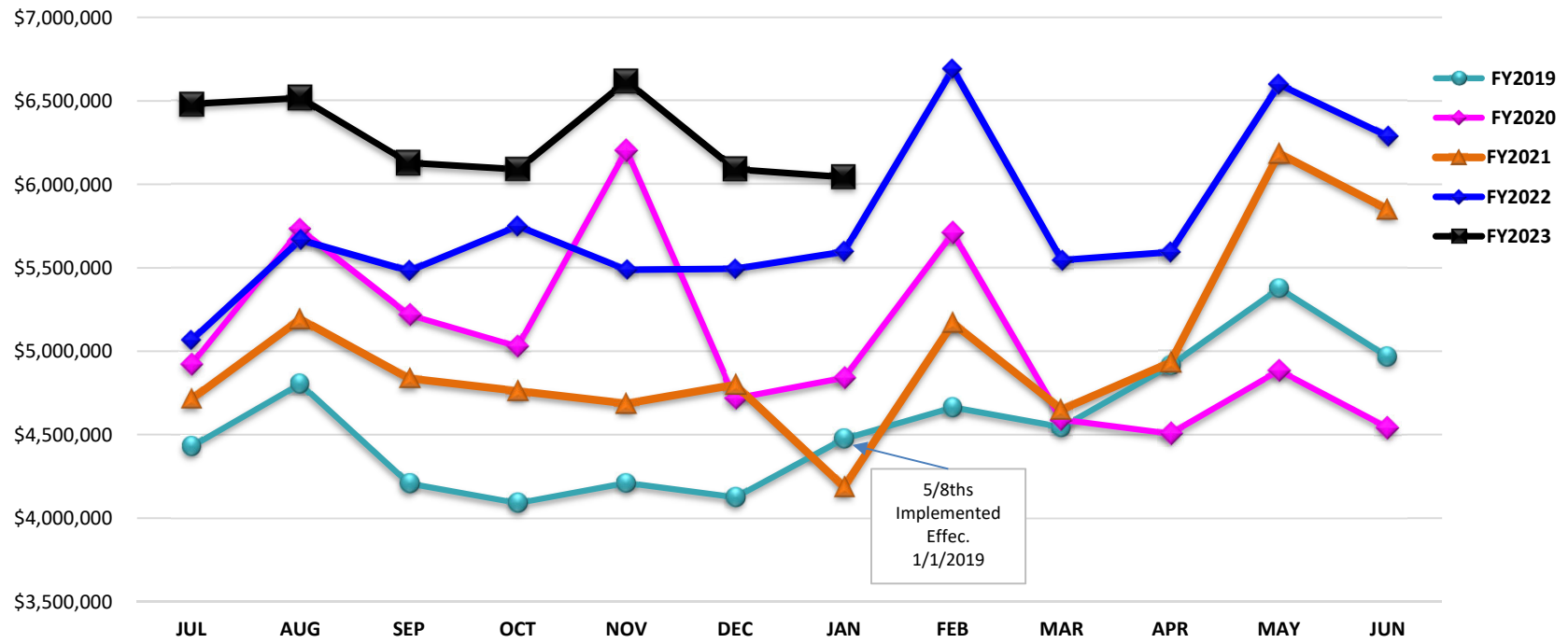
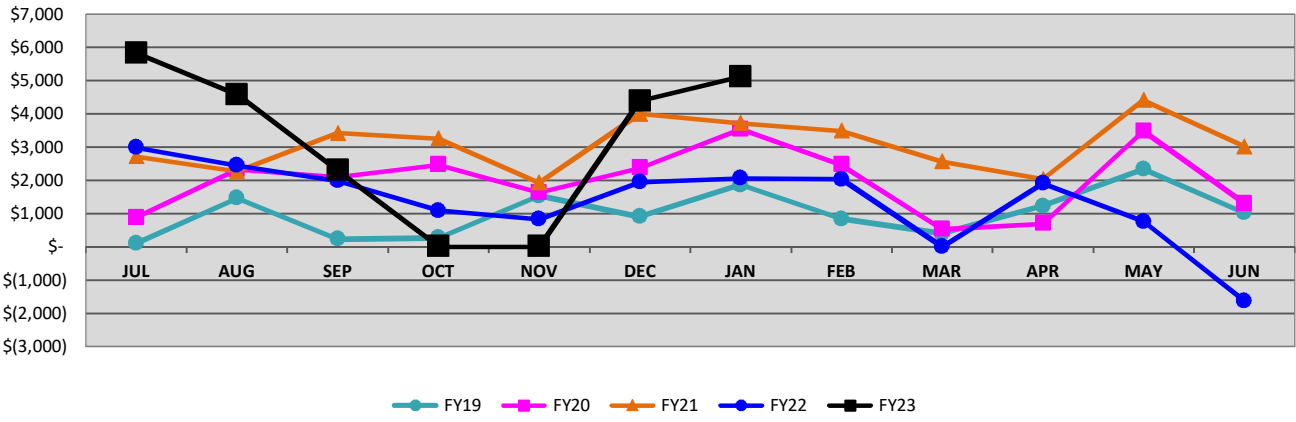


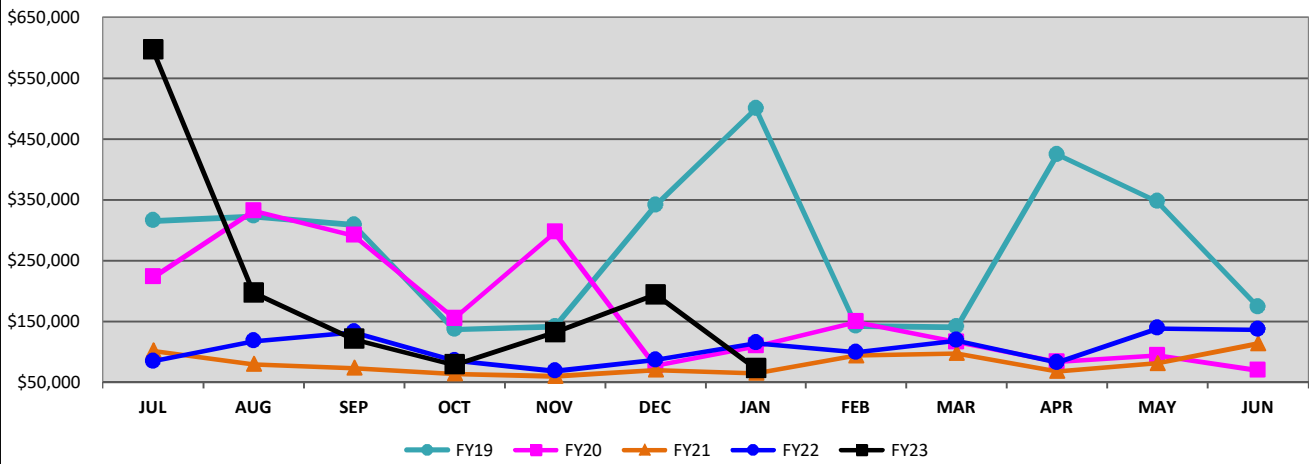
### City of Farmington Gross Receipts Tax Revenue By Month FY2019 - FY2023 YTD



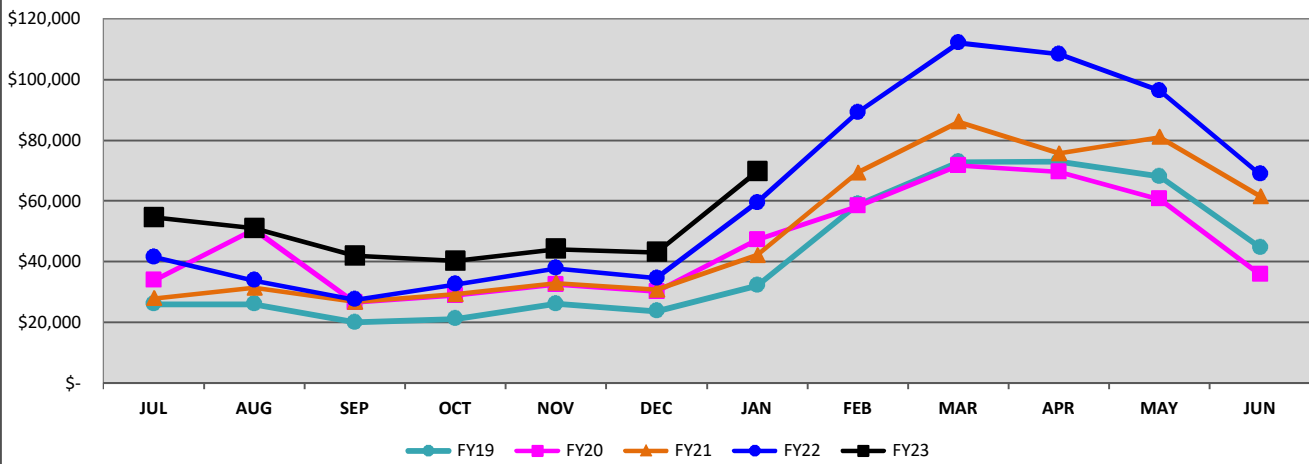
